Unit 1 was traveling in the left lane, in a one-lane construction zone, when Operator 1 lost control of the truck tractor. Unit 1 traveled off the left side of the roadway and into an embankment, where the truck tractor overturned on its left side. Unit 1 remained at final rest. Crash Synopsis:

This crash occurred as Unit 1 was traveling in the right lane on Interstate 80 east bound near mile marked 288.0 located in Tobyhanna Township, Monroe County. As Unit 1 began to negotiate a left curve in the roadway, Unit 1 exited off of the right shoulder. Unit 1 continued off of the roadway and into a ditch located off of the shoulder. Unit 1's trailer then began to rotate counter clockwise, and then impacted multiple trees/shrubbery. After impact with the trees/shrubbery, Unit 1 and its trailer began to overturn onto its passenger side.
